

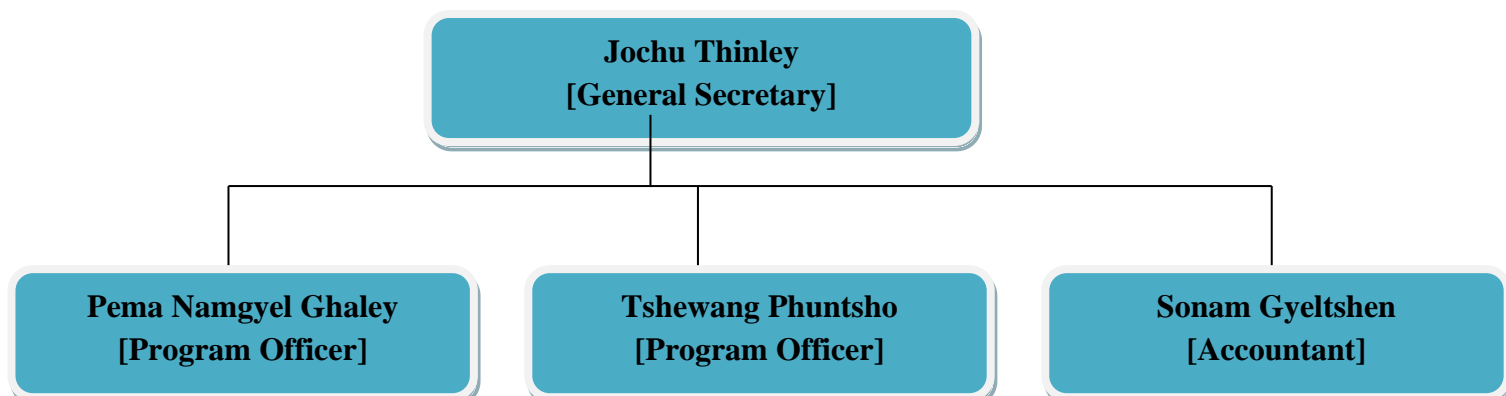

ABI coordinated a meeting with stakeholders as on 06th March 2018 to address the difficulties faced by industries, employees, students and community at large plying in and out of Pasakha due to poor road condition. The Project Manager, SASEC informed the stakeholders that the construction work has started at the ground with effect from 1st January 2018. PM also informed that the construction of Bhalujhora Bridge and Gabion structures at Bawanijhora will be completed by March and May 2019 respectively. To ensure continuous inbound and outbound movement of

goods and people at P.I.E, a task force was formed to communicate and coordinate especially during monsoon.

Training on REX (Registered Exporters Systems)



As Bhutan migrate to the IT-based REX system (Registered Exporters System) from the paper-based GSP system of certification of Rules of Origin by 1st July 2018 to avail preferential treatment given by the EU, Switzerland and Norway, the Department of Trade organized a day long training on May 31st 2018 to all exporters who export to the EU, Switzerland and Norway to register themselves on the system. The training was facilitated by Association to our member industries.

Site visits by Ministries and delegates



The Minister of Home and Cultural Affairs Lyonpo Dawa Gyeltshen and the Minister of Works and Human Settlement Lyonpo Dasho Dorji Choden along with the other delegates, and member industries visited Bhalujhora Bridge site as on 15th July 2018. The site visit was followed by discussion on the ongoing issue of road blockage caused by major landslide near the Bhalujhora bridge.

Awareness program on Postal Ballot facility



In an effort to keep uninterrupted operation of plants & offices of Industries and to exercise franchise during National Assembly election 2018, an awareness program on Postal Ballot facility and its registration processes related was conducted for member Industries of ABI under Chukha Dzongkhag by Dzongkhag Election Officer.

The officials also informed the industries about the net import that occurred in the month of February and March 2018 and its implications as per the DETP 2016. The visit and meeting was facilitated by ABI.

The students and staff of Sarpang Central School visited Pasakha Industrial Estate facilitated by ABI (Tashi Metals Pvt Ltd, Lhaki Steels & Rolling Pvt Ltd, Quality Gases Pvt Ltd and Tashi Beverage Ltd). The objective of their visits was to shape the perspective of students about the industries in the country and highlight career opportunities in the manufacturing sector.

Adulteration of consignment en-route to Kolkata

The Ferro industries faced rampant adulteration of High Value Third Country export/consignment en route to Kolkata Port in the month of September and October 2018.

Association submitted the issue to Consul General, Kolkata, Director, DoT MOEA and Bhutan Chamber of Commerce & Industry to intervene and lobby with the relevant Indian counterparts to resolve the issue at the earliest as it may lead to serious implication on export of goods from Bhutan. Association emphasised the loss is not only in monetary terms but also in terms of credibility of the Bhutanese suppliers.

On 25th October 2018, Association coordinated a stakeholder meeting with the Trade Consul Kolkata and our member industries to discuss the way forward.
