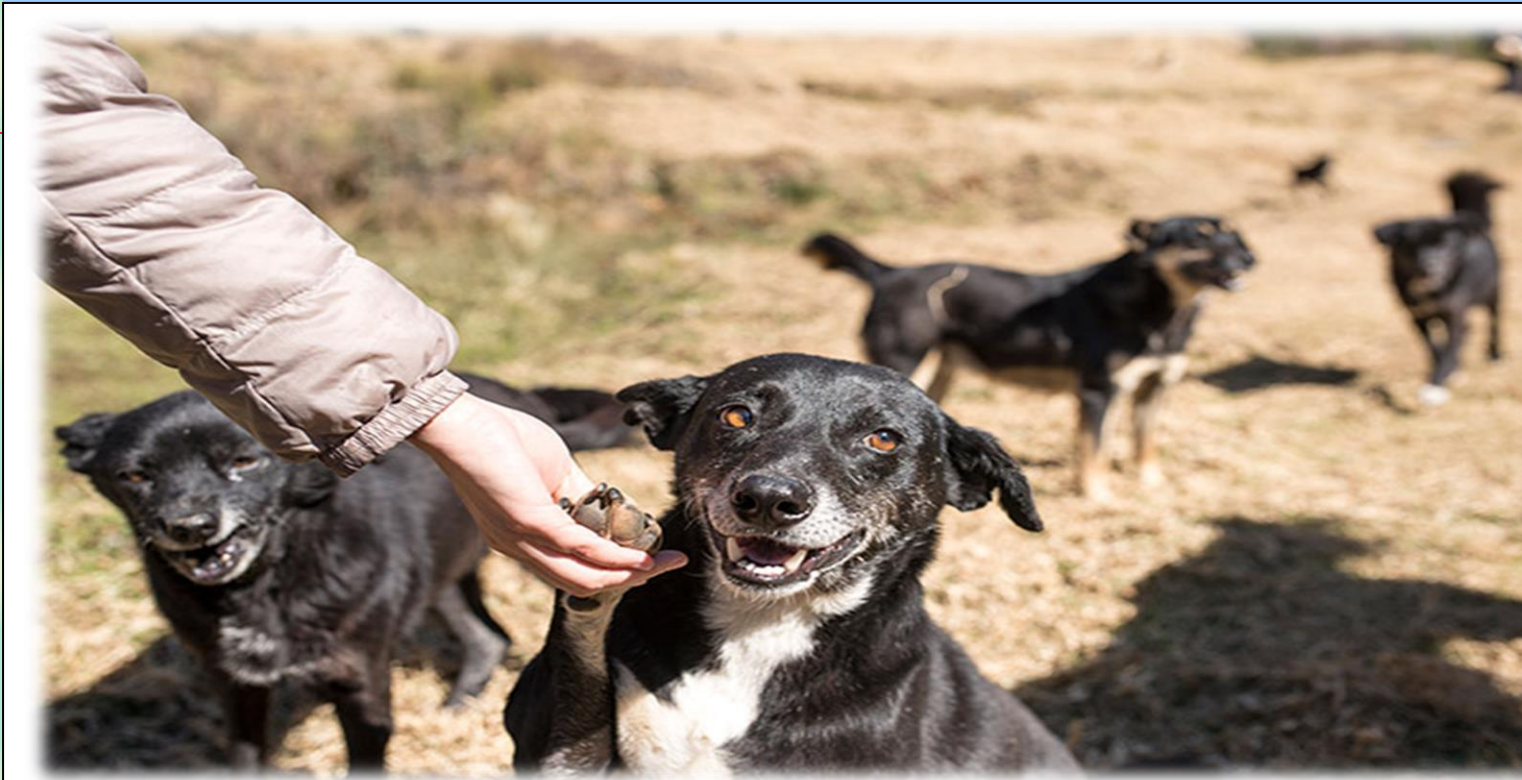

With much pride and gratitude under the Royal Patronage of Her Majesty the Gyalyum *Tshering Yangdön Wangchuck*, and a dedicated board of directors along with a hardworking team, who have selflessly given an immense amount of their free time, I am glad to announce 2017 has been a fruitful journey for the society. I am proud to be a part of this noble initiative and to have joined the Board at a time when the organization is in the process of revamping and creating much change for the betterment of the animals and the environment we live in.

The organization in our Animal Welfare Centre – The House for the Downtrodden has treated 7418 dogs since its set up in March, 2002. In the last year itself, we have accommodated 57 dogs, 2 cows, 2 calves and a mule. The organization has also attended to 37 house calls for veterinary services.

On behalf of the Board of Directors, volunteers and the RSPCA management, I thank you for your extraordinary support. I humbly convey my gratitude to the friends of the society and all ANIMAL LOVERS and well-wishers for your love, compassion and support for our four legged friends.

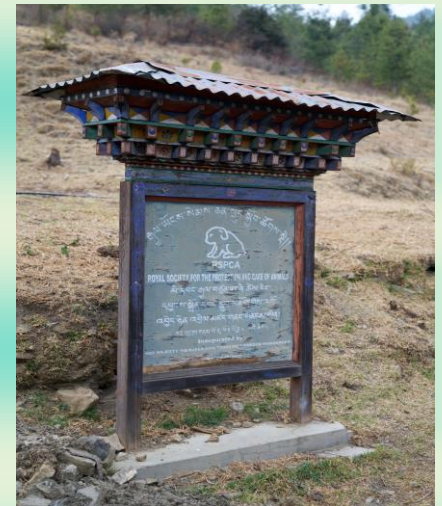

WHO ARE WE?



Founded in 1999, under the Royal Patronage of Her Majesty the *Gyalum Tshering Yangdön Wangchuck*; the Royal Society for Protection and Care of Animals in Bhutan (RSPCA) is the first organization of its kind, fully dedicated for the welfare, protection and well-being of animals in Bhutan. RSPCA is registered as a Public Benefit Organization under the Civil Society Organizations Act of Bhutan 2007.

We work towards rescuing stray animals and providing them with care, stability, medical assistance and lifelong homes, while also solving the stray dog problems and reducing canine related diseases in order to maintain a healthy, safe and manageable stray dog population. Towards promoting the general welfare of animals by raising awareness through public education and campaign and sustaining the Animal Welfare Centre in *Serbithang* – the “House for the Downtrodden” for sick, injured and abandoned animals, which is now home to 87 dogs, 15 puppies, a calf and a bull and a mule.



Vision

A place where mankind and animals can live together in harmony with mutual love and respect and where every life is valued.

The RSPCA, Bhutan will:

Inculcate a sense of moral responsibility for the proper care and humane treatment of animals through increasing awareness on plight of animals in Bhutan and;
Educate proper animal care by way demonstration and dissemination.

To ensure the welfare of the animals;
To work in harmony with all the relevant stakeholders bearing the interest of the animals.

“DARING TO DREAM” (*Tashi Payden’s Story*)

Tashi Payden Tshering had always been an animal lover. Growing up, she would pick random strays from the street and bring them home. She always looked after the stray, but never thought she would one day be the voice for them.

In the nineties on the advice of the WHO, the Royal Government of Bhutan adopted culling as a means of controlling the increasing number of stray dogs in order to prevent the spread of rabies and other canine related diseases.

Tashi, then a fresh graduate approached the Mayor of Thimphu City and suggested ABC (Animal Birth control) as an alternative to culling as a means of controlling the growing stray dog population.



Her idea was welcomed and thereafter along with a group of volunteers, Tashi went around the city every evening collecting waste food from the restaurants and feeding the stray dogs in order to befriend them so that they could be easily rounded up and vaccinated against rabies and sterilized with the assistance of the National Animal Hospital, in order to curb their ever increasing population.

The RSPCA Bhutan, was established in July, 1999 with the approval of the then Council of Ministers (in the absence of an NGO Act then) under the Patronage of Her Majesty the *Gyalyum Tshering Yangdön Wangchuck*. The society has a clearly formulated vision in its Charter and an active Board of nine Board of Trustees from both private and the Royal Government of Bhutan. In the same year, the RSPCA, Bhutan received a plot of land in suburban Thimphu from the Government on lease for the construction of an Animal Care Centre.

In 2002 the RSPCA managed to obtain fund from the Sustainable Development Secretariat, which enabled them to construct the animal shelter. This shelter has been operational ever since.

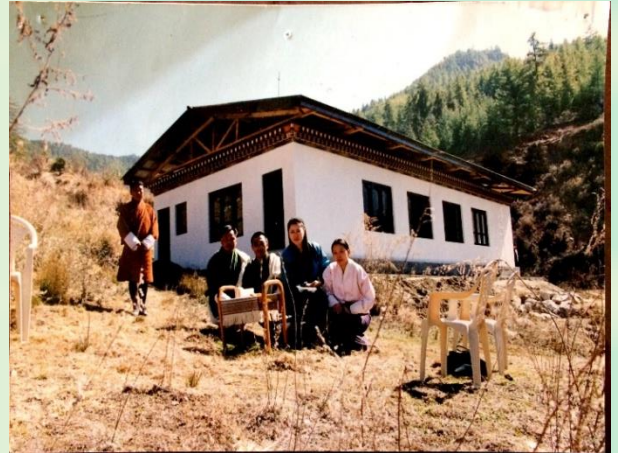

Renovation Plan (Our New Shelter)

“Building a Better World”

At more than 16 years old, our shelter has outlived its useful life. Although amazing work happens within its boundary, the small size of our facility prevents best practices that could save even more lives.

Our dream of a new shelter and a better world for animals would have remained a dream if not for the helping hand from Welttierschutzgesellschaft e.V. (WTG) Berlin, who is making our dream into a reality by funding our renovation plan.



ACTIVITIES

2017 has been a great year for the organization. For the first time in 19 years, RSPCA revamped itself with the support from friends, families and animal lovers. It was by far the most active year for the organization whereby, we strengthened the organisation by hiring additional staffs and actively advocated on animal welfare. Following are some of our achievements for the year:

1. Sterilization Campaign

In order to curb the ever increasing stray dog population, we ensure that all sick dogs at the shelter after they are treated from other diseases for which they are brought in are sterilised, vaccinated and dewormed. Including rescued dogs, puppies and biting dogs that are rehabilitated at the shelter.

These dogs and other animals are sterilised and treated with the help of the team from the National Animal Hospital.



2. Working with the Community

Food collection from Kuenselphodrang where devotees from around the country gathered for Kanjur oral transmission for 3 months.

Also collected from hotels and restaurants: Namgay Heritage, City Hotel, San Maru – Korean restaurant, Hotel Pedling and from Royal Thimphu College.



3. Mass Cleaning Campaign



Volunteers of Young Geykuel Drukdra (YGD) a group of energetic volunteers visited our shelter twice and got involved in all of the shelter's activities, starting from bathing the puppies to grooming to cleaning. They also assisted our team with therapy treatment for our recovering animals and accompanied our caretakers to fetch fresh grass for the stray domestic animals at the shelter. And by the end of a day long program, our shelter had never looked better and animals any happier. Volunteering is one way to make a difference and we are very grateful to these lovely volunteers for their commitment of time and energy and their generous contribution of food for the animals at the shelter.



4. Veterinary services

Aside rescues, the Society also took in house call, whereby we vaccinated 15 pets for rabies and kept track of vaccination requirement to ensure all vaccinations and follow up treatments are done in time.

PROGRAMS

1. BUDDIES PROGRAM

In RSPCA "Buddies program", we take the children for a tour of our shelter. The dogs clearly love it. This helps the children learn about the value of life and to develop mutual love and trust.

The tou is supervised to ensure safety of both kids and the animals. Besides young children, we also have residents and tourists join us for the program.



2. MEMBERSHIP

Members enjoy many benefits, including a subscription to our half yearly newsletter and the opportunity to visit our shelter any time of the year. In addition, we keep you informed of RSPCA's progress with special mailings as well as an annual report.

The Society recruited a total of 44 members from all walks of life: Students, Civil servants and residents.

3. FOSTERING

Foster a pet! Every year we need dozens of foster homes to help raise litters of puppies and kittens. We also need foster homes to help socialize dogs so that they can become great pets for adopters.



4. ADOPTION

For people interested in adoption, we have “Meet and greet” session, where we guide the interested visitors around the shelter, have them interact with the dogs, give them treats and see if they feel a bond with anyone in particular. The interested adopter then fills out an adoption form and is free to take home a lifelong companion.



5. SPONSORSHIP

Sponsorship is for people who want to help but are unable to foster or volunteer. The sponsor can visit our shelter and personally pick a dog. We send a monthly update on how your furry friend is doing.

Aside from sponsoring an animal, you can also sponsor small projects at the shelter like upgrading the kennel and improving the physical environment of the shelter.

6. VOLUNTEERING

Volunteering activities include:

- Transport animals from shelters, foster homes or veterinarian appointment
- Help with administrative tasks
- Help with fundraising drives and campaigns
- Collection of waste food from hotels and restaurant
- Grooming
- Maintenance/Up keeping: Wash bowls, clean visitors area, kennels etc
- Assist adoption events or help our team with event coordination
- Help with fun special events such as Buddies program
- Be an outreach ambassador to spread our mission in the community
- Become a foster parent and take needy animals to your home for specialized care
- Help physically and mentally stimulate the pets in our care.

In partnership with WTG

Welttierschutzgesellschaft e.V. (WTG) is a Berlin/Germany based registered non-profit organisation. Their vision is “A world, in which animals are appreciated by people, treated according to their needs and with respect”.



They aim at improving the situation for animals in the long term i.e. by providing veterinary care, by supporting animal sanctuaries and through educational work, WTG cooperates with local partner organisations. WTG has partnered with RSPCA for the period September 2017- October 2017 and is financially supporting most of the activities of the RSPCA along with the part of the renovation work at the shelter.

Over the span of 19 years, the Society has been able to look after the welfare of animals and carry out its activities with support of the above mentioned.

HERE'S SOME OF OUR RESCUE STORIES

1.

We first heard of *Mindu's* condition from a friend of the Society. The RSPCA and NAH team picked him from *Pamtsho* (North-East of *Thimphu*), with help from Mrs. *Tshoki Khandu*, who helped arrange transportation. The docile mule was little more than skin and bone when he was found with a large tumour on his scrotum. He was immediately taken to our welfare centre in Serbithang where he was given emergency treatment and monitored daily.

Mindu had a tumour in his scrotum. He underwent surgery performed by the team from the NAH with drugs provided by NCAH. The 5 hours operation involving 1 doctor, 3 para-vet and 2 caretakers, managed to successfully remove his tumour.

He is now doing well, exhibiting great attitude and back to his feisty self.

He was recently released from the shelter but can be seen around the Serbithang area with other *tshetharequine* (animals saved from slaughter/freed from workload) but comes by to say hi. 😊



2.

A mother of nine beautiful stray puppies was shot dead during an archery game in *Kabeysa* (North-East of *Thimphu*). RSPCA immediately stepped in knowing the chances of their survival without their mother were slim to none. The nine feisty week old puppies were pulled to safety and then moved to our shelter in Serbithang, where they were fed and given warm beds and blankets to sleep in.

Despite all our efforts, only 3 of the 9 puppies survived. The surviving puppies were immediately given for adoption. Now named Carmella and Sugar, they are a happy member of *Sonam Wangchuk's* family and surprises us with occasional visit to office.

The third puppy was adopted by a teacher for his son. He is now a proud guard dog who walks his son from school every day



3.

Staffs of *Gyalwa Dokhampa*, rescued a calf caught in tar from a construction site in *Hongtsho* (East of *Thimphu*) and rushed him to our shelter.

Volunteers found him covered in tar that had leaked out of a large container. Unable to move, terrified and dehydrated, he was stuck for three days before being rushed to our shelter for emergency treatment.

It took a team of 5 people and 6 hours to soften his skin by rubbing vegetable oil over the tar to free the poor calf. This was followed by daily salt therapy treatment to improve his muscle movement. Days later, tar-free and full of energy, our strong calf made a steady recovery from his frightening incident but unfortunately passed away a month later.



4.

A 9 months old Apsua, *Snowy* went missing for a month. *Dezang*, *Snowy's* owner was heartbroken and they canvassed the neighbourhood, updated social media, plastered posters and got in touch with vet's offices looking for him and also contacted the RSPCA for help.

Mrs. *Tshering Yangzome*, our Board Member, found him in a very pathetic condition - just skin and bones with one eye blind, severe flea problem and cuts around his lower back. He also had severe matting that affected his ability to see, walk and eat normally. Our team and Ms. *Tshering Yangzome* together had him sedated before rushing him through the grooming process of trimming and getting the fleas out.

The reunion was an emotional one. When *Snowy* saw *Dezang's* mother walk in, even while sedated, he dragged himself to lean on her. He could tell he was finally home. And within the weekend, he was back joyfully lapping at their faces. 😊

This young calf was rescued by volunteers and brought to National Animal Hospital for emergency treatment. He was hit by a truck that resulted in a wide open wound on left side of his ribs which was left unattended for weeks. When he was sent to us to be accommodated at the shelter, his wound was infested with maggots.

Our team took great care of him and within a week, his wound started healing and closing. Renamed *Dokha* by our caretaker, meaning white face, he has now been a resident of our shelter for more than 5 months. He is a curious soul who gets along very well with the visitors and fits right in with the other dogs. ☺



6. Engi

RSPCA also accommodates a lot of biting dogs, Engi is one of them. He was a guard dog in a monastery and was brought in after he bit 8 people, who were visiting the monastery.

It took him a while to open up to us but he is now one of the most loving dogs. He loves sharing hugs and kisses and is always there to welcome guests at the shelter.

Engi's change of character is RSPCA's pride. ☺

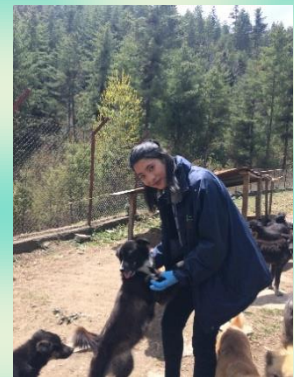

Auditor's Report on the Financial Statements



Audit Findings & Recommendations

AUDITORS' REPORT ON THE FINANCIAL STATEMENTS OF THE ROYAL SOCIETY FOR PROTECTION AND CARE OF ANIMALS, THIMPHU FOR THE FISCAL YEAR ENDED 30 JUNE 2017

We have audited the accompanying financial statements of the Royal Society for Protection and Care of Animals, Thimphu which comprises of the Receipts & Payments Statements, Schedule forming parts of Receipt and Payment Statement and list of assets for the financial year 30th June 2017, as required under the Audit Act of Bhutan 2006 and as per the Terms of Reference issued by the RAA vide letter RAA(OSA-06)/AC/2018/309 dated 9th February 2018.

Management's responsibility for the financial statements

Management is responsible for preparation and fair presentation of these financial statements in accordance with Financial Rules & Regulations 2001 & 2016. This responsibility includes, designing, implementing and maintaining internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error, selecting and applying appropriate accounting policies, and making accounting estimates that are reasonable in the circumstances.

Auditor's responsibility

Our responsibility is to express an opinion on the financial statements based on our audit. We conducted the audit in accordance with RAA's Auditing Standards and Generally Accepted Auditing Standards (GAAS). Those standards require that the Auditor complies with the ethical requirements and plan and perform the audit to obtain reasonable assurance about whether the financial statements are free from material misstatement.

Scope of Audit


An audit involves performing procedures to obtain audit evidence about the amounts and disclosures in the financial statements. The procedures selected depend on auditor's judgment, including the risk of material misstatement of the financial statements, whether due to fraud or error. In making those risk assessments, the auditor considers internal controls relevant to the entity's preparation and fair presentation of the financial statements in order to design audit procedures that are appropriate in the circumstances, but not for the purpose of expressing an opinion on effectiveness of the entity's internal control. An audit also includes evaluating the appropriateness of the accounting policies used and the reasonableness of accounting estimates

made by the management, as well as evaluating the overall financial statement presentation. We believe that the audit evidence obtained by us is sufficient and appropriate to provide a basis for our audit opinion.
